

Memorandum of Understanding

This Memorandum of Understanding (hereinafter referred to as MoU) is made and executed on this 15th day of January 2021 at Sadavali,

Between

Prabodhan Shikshan Prasarak Sanstha's, Indira Institute of Institute of Pharmacy, a residential institute approved by All India Council of Technical Education, Pharmacy Council of India and Directorate of Technical Education, Mumbai, Govt. of Maharashtra having an address at: At Post –Sadavali, Tal.- Sangameshwar, Dist. Ratnagiri, and Pin – 415 804.
Through its Principal.

(Hereinafter referred to as IIPS)

And

Dr. Dhane Clinic, a residential hospital approved by Govt. of Maharashtra has an address at: Arihant Nagar, At Post –Sadavali, Tal.- Sangameshwar, Dist. Ratnagiri, and Pin – 415 804.

(Hereinafter referred to as DC)

WHEREAS:

- A. IIPS, a technical institute established in 2008 by Prabodhan Shikshan Prasarak Sanstha, Ambav, a renowned registered public charitable trust is running various institutions in the region since 1997. The degree and diploma courses are approved by AICTE, PCI, MSBTE, and DTE. The B.Pharm course is affiliated to Mumbai University while the diploma course is affiliated to Maharashtra State Board of Technical Education, Mumbai (MSBTE).
- B. DC is run by a visionary doctor from the Sadavali region giving all possible health services under one roof which include a multispecialty clinic, a well-established pharmacy section. The aim of the hospital is to provide quality and economical health service to the peoples of the Sadavali region.
- C. IIPS and DH mutually agreed to manage Biomedical waste of the institute in which following items will be deposited for decontamination purpose.
(Items- Used petri Dishes, Syringes, Animal Waste, Any other biologically hazardous material)

NOW THIS AGREEMENT WITNESS AND IT IS AGREED UPON BY AND BETWEEN
THE PARTIES AS UNDER:



1. Scope of MOU:

- a) This MOU aims to benefit all the stakeholders & for career opportunities to develop entrepreneurship instincts in the students of IIPS.
- b) The stakeholders are Students of the Institute and Dr.Dhane Clinic, Sadavali.

2. Benefits to stakeholders:

a) Benefits to Students:

1. Understand the Procedure for the handling of biomedical waste.
2. To make aware students and staff about ways and means of handling such waste materials.

b) Benefits to Institute:

1. Management of Biomedical waste of the IIPS.
2. To sensitize students about how hospital Systems work synchronously.
3. It will help to create awareness among the students about the environment.

3) Terms of the Agreement:

The term of this MOU is for **3 (Three) years** commencing from the date it is signed by a representative of the two institutions. The parties may decide to further extend the term of this MOU by mutual consent on terms and conditions as may be agreed between them.

4) Further Agreement:

This MOU will be reviewed after **three years**; the terms of this MOU may be amended by mutual written agreement prior to the date of review. Any extension to this MOU will be formally agreed upon in writing by the parties.

5) Amendment/Termination of MOU:

- i) Any amendment to the terms of this agreement can only be made by mutual consent of the parties.
- ii) Either institution may terminate the MOU by giving written notice to the other institution six months in advance. Once terminated, neither IIPS nor DC will be responsible for any losses, financial or otherwise, that the other institution may suffer. However, IIPS nor DC will ensure that all activities in progress are allowed to complete successfully.

6) Confidentiality:

- i) The Parties agree to maintain strict secrecy and confidentiality regarding any and all confidential Information exchanged or to be exchanged between them in relation to this agreement.
- ii) Information and material disclosed and provided by each party to the other party in pursuance of or in connection with the performance of its obligation under this agreement, shall at all times remain the sole and exclusive property of the disclosing Party.



7) Applicable Law and Dispute Settlement:


- i) This agreement shall be governed by the Laws of India
- ii) Any dispute arising between the parties in connection with or arising out of the performance of mutual obligations under this MOU shall be resolved in a spirit of independence, mutual respect and shared responsibility by mutual discussion, and consultation. If the dispute remained unresolved even after 30 days, then the dispute shall be referred to Dr. B.C. Hatapakki, Principal of IIPS and Dr. Swapnil Dhane, Medical Practitioner of DC. The decision of Dr. B.C. Hatapakki and Dr. Swapnil Dhane shall be final and binding on both parties.

8) Originals:

This Agreement is executed in counterparts, each of which shall be deemed to be original and retained by each of the Parties but together they shall constitute one and the same agreement IN WITNESS WHEREOF, the Parties hereto have put their hands the day, month and the year first hereinabove mentioned.




