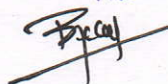

ADMISSION RULES

DIRECT SECOND YEAR PHARMACY ADMISSION 2026-27

- The application of the candidate should reach the authorities on or before the scheduled date and time. The application received after the designated date and time will not be considered for admission.
- On the day of admission, upon arrival (Well in advance as per schedule displayed on website: <http://www.iip.ind.in> and notice Board), Candidate shall report to the reporting counter kept at the porch adjacent to the Administration Office at the College Main Building. Candidates must sign the attendance register with the date & time.
- Candidates will be considered as reported only after signing the attendance register.
- Candidates shall present all applicable documents in original to the competent authority for verification. Only upon successful verification of all relevant documents, candidate will be considered eligible for the admission procedure. In case the candidate has already taken admission at any other Institute, he/she shall submit the relevant document pertaining to his/ her admission.
- After successful verification of all relevant documents, the candidate shall wait in the allotted Classroom.
- Candidates will be called according to merit number. Candidate shall respond immediately in his/ her own interest and should report to the admission committee.
- If any candidate fails to report after calling out his/her name, the next candidate in the merit will be called and such non reporting candidate will be considered only at the end of admission round, if any seat is available.
- After confirmation of admission from the admission committee Candidate shall report to the Office Superintendent to initiate the procedure for admission.
- Candidates must have all original Certificates and mark-sheets along with 3 photocopies of each Fee will be accepted by Cheque or UPI transaction.
- All rules and regulations as prescribed by Competent Authority will be application for these admission and admission process.
- Candidates reporting for admission are hereby considered to have seen these rules and is bound by these rules.
- The confirmed admission will be subjected to all the rules and guidelines as prescribed by state CET Cell, ARA & other competent authorities.
